Office Copier Lease

Background

The Workforce Alliance released a request for proposals (RFP) for Office Copiers on July 2, 2024 The current lease with Digital Office Systems (De Lage Landen) expires in October 2024. The RFP closed on July 30, 2024 and four proposals were received.

Analysis

Staff has reviewed the RFP and submissions to ensure it meets the requirements and has complied a cost comparison. Staff also meet with each of the potential vendors to validate the proposals and ask questions. Below is a table with the evaluation of the proposals. The annual cost below includes the copy machine lease, and estimated print cost based on 2023 printer totals and costs for printing software. The lease will only include the machines and software, printing costs will be paid monthly or quarterly directly to the copy machine vendor.
