### **Item**

Workforce Innovation and Opportunity Act (WIOA) Youth Program Update

# **Background**

Program Year 2022 (PY22) began on July 1, 2022 and ended on June 30, 2023. While program year 2022 is over, performance will not be complete until the end of August. Program Year 2023 has just begun; reporting for Program Year 2023 will begin in the next few months.

Youth staff and leadership have been focusing on outreach activities targeting potential participants and employers. The goal of this outreach is to increase the number of participants in the program and the number of employers willing to engage in work experience opportunities.

### **Analysis**

## Outreach and Partnership Activities

Outreach activities continue to take place and are assisting in increasing enrollments. Youth staff continue to present on services at the Wichita Children's Home Crossroads Program and are in discussions to possibly begin providing resume classes there as well. WIOA Youth staff has worked with the Workforce Alliance's communications department to update all the WIOA Youth flyers and the WIOA Youth web page on the website. Outreach activities have resulted in a significant increase in enrollments. In Program Year 2021, 74 customers were enrolled in the program. In Program Year 2022, 114 customers were enrolled in the program. That is an increase of 40 participants. Staff continue to work on recruiting new work experience sites. Two new work experience sites have been developed. The new work experience sites are Bin Shop'n and Bill's American Muffler Shop.

### Success Stories

Hannah is a person with a disability and was referred to the program in January 2023 by Cerebral Palsy Research Foundation (CPRF). Hannah had recently moved to Kansas from another state where she had completed a Bachelor of Fine Arts. She was working as a para-educator but wanted to find a career in her field of study. Hannah took advantage of many WIOA Youth services before moving on to a Work Experience. The WIOA Youth team worked together to find a work experience for her in her field of interest at a new work experience site. The program purchased the Adobe Creative Suite for her to use at her work experience. The work site reports that Hannah is doing excellent at her work experience and they are interested in hiring her after her work experience. Hannah is exited about her career and the opportunities created by participating in the program.

Bryan is a single father who visited the Workforce Center looking to make a career change and gain self sufficient employment. He was recently unemployed and was struggling to afford rent and support his child. Bryan was previously employed as an Auto Detailer but this employment had no benefits and was not enough to support him and his child. Bryan enrolled in the WIOA

Youth program seeking training in the transportation industry. He began training at a local CDL provider and successfully completed training in five weeks. Bryan really appreciated the small class size and attention he received from his instructor at the training provider. Bryan passed his CDL testing on the first try and secured employment as a local route driver. He now makes \$21.00 an hour, works full time, is eligible for benefits, and is able to be home each evening for his child. Bryan feels his life is on a significantly better track and appreciates the assistance he received from the program.

## WIOA Youth Performance (PY22)

The Youth Program projected annual performance is to exceed the goal for Placement in Employment, Education, or Training 2<sup>nd</sup> Quarter, Placement in Employment, Education, or Training 4th Quarter, Credential Rate, Measurable Skills Gain, and Median Earnings.

Local Area IV (LAIV) is projected to do a little better than the State in annual performance. LAIV is projected to exceed the goal for all five measures. The State is projected to exceed the goal for three measures and meet the sanction level for two measures.

### WIOA Performance Average Indicator Scores (PY22)

For Average Indicator Score LAIV is projected to exceed the goal for Employment 2nd Quarter, Employment 4<sup>th</sup> Quarter, Measurable Skills Gain, and Median Earnings, and meet the goal for Credential Rate.

For Average Program Score LAIV is projected to exceed the goal for the Adult, Dislocated Worker, and Youth programs.

For Average Indicator Score the State is projected to exceed the goal for Employment 2nd Quarter, Employment 4<sup>th</sup> Quarter, and Median Earnings, and meet the sanction level for Credential Rate and Measurable Skills Gain.

For Average Program Score the State is projected to exceed the goal for the Adult, Dislocated Worker and Youth programs.
